NOTE TO APPLICANTS:

The licensing fee is \$25 for an anhydrous ammonia bulk storage facility or mobile storage container (farm/private) exceeding 6,000 gallons (22,712.47 liters) of storage capacity and \$100 for each retail bulk storage facility or retail mobile storage container (\$100 for combined retail and storage). The license is valid indefinitely, but may not be transferred. For a facility to sell anhydrous at retail in North Dakota, a fertilizer distributor license is required in addition to an anhydrous ammonia license.

No permanent anhydrous ammonia storage facility or mobile storage container may be operated without a license issued by the Commissioner of Agriculture. Before constructing a new facility, initial approval must be obtained from the board of county commissioners in the county which the facility is to be constructed. The Department of Agriculture will submit the application to the county for signature. Mobile storage containers must submit all designated downloading locations.
